## **NOMINEE**

Gary Boshears, Chief of Police  
Granite Shoals Police Department  
Individual Member of Region B

### **1. List your current and/or past service in the movement against sexual assault or the experience you bring that is relevant to TAASA board membership.**

I have over 17 years of experience as a law enforcement officer including experience in corrections, patrol, investigations, and administration. While working in investigations and now in administration, I have worked to make our investigations into sexual assaults more focused on the needs of the survivor and have worked to implement trauma informed principals into our investigations. Our agency is currently implementing new approaches to these investigations designed to reduce the number of times a survivor must tell the story of their assault while also enhancing our ability to investigate and prosecute these crimes. Additionally, since 2013 I have served as a trainer for the statewide Sexual Assault Family Violence Investigator Course and have trained several hundred law enforcement officers across the state in this program.

### **2. List the strengths/special skills/background you bring to TAASA board service and/or to this particular board position.**

As a law enforcement officer, I have been an advocate for sexual assault victims and for implementing law enforcement programs to aid survivors in recovery. I have extensive experience in training law enforcement officers in sexual assault investigative techniques and focus on training these officers on trauma informed approaches to investigations. Additionally, I have a Bachelor's of Science Degree in Criminal Justice and a Master of Public Administration Degree.

### **3. List what goals, expertise and skill set you would bring to the TAASA board if elected.**

I have extensive expertise and skills in law enforcement investigations into sexual assaults and trauma informed approaches to those investigations. I have implemented new programs within my department to enhance our responses to these crimes. I have extensive experience as a law enforcement trainer on this topic as well. A goal of mine would be to have TAASA working closely with law enforcement trainers and programs to ensure that officers who investigate these crimes have received the latest in training trends and techniques so they are in a better position to provide the highest quality of service to sexual assault survivors. I would also like to see TAASA advocate in the legislature for more required training for law enforcement in the area of sexual assault investigations. Many law enforcement officers only receive basic training on this topic and little continuing training. I believe more training and continuing training for law enforcement on this topic is a necessity.

**1. List your current and/or past service in the movement against sexual assault or the experience you bring that is relevant to TAASA board membership.**

I am currently working on a school based prevention-like-program which seeks to build community with local law enforcement officers, school counselors, and students using relationship practices. I previously worked for a number of years in direct service as a Legal Advocate, and for the past 7 years I have been deeply involved in the anti-sexual assault movement. What started as volunteering in an area I was very passionate about, has since turned into a career of advocacy. During my undergraduate career I had the opportunity to start the first survivor's support group on campus, as well as help organize awareness campaigns among the student body. I have also been involved in several local SARTs, working to facilitate community collaboration, education, and advocacy. I have been involved in the TAASA Diversity Task Force over the past few years, and on the TAASA Board of Directors for the past term. I want to continue to be involved in the movement across the state.

**2. List the strengths/special skills/background you bring to TAASA board service and/or to this particular board position.**

I have a Master's Degree in Victim Services Management, and previously worked in direct service, as well as had the opportunity to intern at the state capital. Having worked in these various areas in addition to working directly with law enforcement, has given me a unique perspective into the challenges faced by sexual assault survivors. Working directly with clients has allowed me to see how our systems impede the survivor's access to resources, and also their ability to heal. One of the duties of my previous position was being an on-call advocate who accompanied sexual assault survivors to the hospital for a SANE exam. I have seen firsthand the devastating impact it has on survivors when the hospital and other community partners are not trauma informed.

**3. List what goals, expertise and skill set you would bring to the TAASA board if elected.**

I want to help grow the vision of TASSA, by effecting change from the legislative level, down to the best practices and procedures of first responders. One of the most frustrating situations I have come across are cases where sexual abuse of a child is reported, and the agencies involved take weeks to respond. I want to help advocates across the state that are in similar situations by providing resources and assistance. I want to help give a voice to local direct service staff because they are the ones on the front lines, it is imperative that their voice be heard in this movement. Through my experience working with sexual assault survivors in the legal system, I believe I can help identify additional barriers faced by survivors every day. I want to make networking and fostering relationships between agencies across the state a priority, in order to help remove barriers to justice for survivors.

**1. List your current and/or past service in the movement against sexual assault or the experience you bring that is relevant to TAASA board membership.**

I have been a police officer for approximately 18 years. For the past 3 1/2 I have supervised the Waco Police Department Crimes Against Children Unit. I would estimate that more than half of the cases worked by my Unit (approx. 1200/yr) are of sexual assault. I also am a member of the Heart of Texas Human Trafficking Coalition and serve on it's Steering and Prosecution & Protection sub-committees.

**2. List the strengths/special skills/background you bring to TAASA board service and/or to this particular board position.**

I have a TCOLE Master Peace Officer License. I am a TCOLE certified instructor. I am currently working on my masters degree in criminal justice. I present classes on the role of law enforcement of child abuse investigations, digital and social media evidence for investigators, and the recognition of domestic minor sex trafficking as child abuse.

**3. List what goals, expertise and skill set you would bring to the TAASA board if elected.**

Law enforcement can be it's own worst enemy when it comes to serving survivors of sexual assault. Through my work with the HOTHTC I have seen how collaboration and a holistic, victim centered response can bring successful outcomes and positive perceptions.

**1. List your current and/or past service in the movement against sexual assault or the experience you bring that is relevant to TAASA board membership.**

As a seasoned sexual assault investigator, I would bring an opened minded criminal investigation based perspective to the board. This could provide a real-world basis that could prove to be valuable in the decision making process, because I have experience interviewing survivors and actors. The firsthand knowledge obtained through those interviews could be presented, modified, and/or used to improve services.

**1. List your current and/or past service in the movement against sexual assault or the experience you bring that is relevant to TAASA board membership.**

As a sex therapist/educator, I work to advocate for sexual minorities, specifically educating professionals about working with kinky and poly clients. Research indicates that a fairly large portion of those with alternative sexualities either fear they will be or are being discriminated against (or worse) and I work to fight against that by educating professionals locally (hopefully nationally, if my presentation proposals are accepted by the American Association of Sexuality Educators, Counselors and Therapists and Loving More conferences).

**2. List the strengths/special skills/background you bring to TAASA board service and/or to this particular board position.**

I have a Master's degree in Social Work, am a board certified social work supervisor, have presented at several conferences (including TAASA), assist in the development of new platforms for educating about alternative sexualities (volunteer with the planning committee for PolyDallas Millennium), am excellent at researching/planning, have been able to start my own therapy practice (since 2012) and grown it to now have a total of 3 employees, have volunteered with the Plano Crisis Response Team, and I see trauma clients every day of every week.
