### **1. List your current and/or past service in the movement against sexual assault or the experience you bring that is relevant to TAASA board membership.**

I started working at Harris Health as a Forensic Nurse Examiner in 2011 and immersed myself in the field. In 2015, I became the Program Manager of Forensic Nursing Services, and was responsible for the day to day management of the department. After achieving my doctorate, I decided to pursue my goal of teaching, and is currently an Assistant Professor at Houston Baptist University.

I currently serve as the International Association of Forensic Nurses (IAFN) Board as Secretary, and have served as the Board liaison of the Strangulation Task Force, Title IX Task Force and the Suspect Exam Task Force. I am also currently the IAFN Texas Chapter's President and serve on the Chapter's Education Committee.

I am currently working on a collaborative project in Harris County addressing the standardization of care for patients who have been strangled. This project is multidisciplinary and includes advocates, law enforcement, the district attorney, as well as other crucial stakeholders.

I have many strengths that qualify me for this position. I am a natural leader and I take great pride and responsibility in all that I do.
